Please note: No preferences are required to place a deposit, and preferences are never guaranteed to appear in the next litter.

A deposit of \$500.00 will be paid to hold the Buyer's position in line to purchase a puppy and is **NON REFUNDABLE.**

The deposit goes toward the final purchase price. The purchase price is also NON-REFUNDABLE. See below for further details on this sale.

Deposit: \$500.00

Final Puppy Price: \$2000 to \$2500*

Breeding rights are an additional cost and not included in this price

SELLER AGREES:

- To provide a copy of the deposit contract to the Buyer once payment is received.
- That deposit amount will be deducted from the total price of the puppy.
- Deposit is non-refundable for all reasons possible. Seller owes no debt to Buyer if, for any reason, Buyer does not complete payment or changes mind about purchasing a puppy.
- Deposit is transferable to future litters up to and not to exceed three times after the original intended litter. After three litter transfers, the deposit is considered canceled by the Buyer. The Seller will make no refund and should the Buyer inquire about future litters again, a new deposit must be placed.
- To notify the Buyer of the date that the remainder of the payment is due.

BUYER AGREES:

- That deposit amount will be deducted from the total price of the puppy.
- Remainder of the total price of a puppy is due to be paid the day the puppy has transferred ownership from Seller to Buyer.
- That deposit is NON-REFUNDABLE for all reasons possible. Should the Buyer change their mind about purchasing a puppy, not pay in full at the time of transfer, or ANY other

reason that results in the Buyer NOT receiving a puppy, NO REFUND will be made in ANY amount.

- The order of deposits received determines the pick order and that placing a deposit holds their spot in the pick order deposit list for a future puppy. NO REFUND will be given if the timing of litter changes for any reason, including but not limited to breeding not taking for all reasons beyond the seller's control.
- Picks are made after the puppies are 6 weeks old. The Seller will contact the Buyer when it is their time to pick. Buyer may choose from the available puppies at that time or choose to skip the current litter and hold their place in the deposit line for a future litter.
- If the Buyer does not respond within 48 hours of the Seller attempting to make contact, the Seller may allow the subsequent deposits on the list to make their picks.
- Deposit is transferable to future litters up to and not to exceed three times after the original intended litter. After three transfers, the deposit is considered canceled by the Buyer. The Seller will make no refund and should the Buyer inquire about future litters again, a new deposit must be placed.
- To collect the puppy by 10 weeks old or by the agreed-upon go-home date. Should Buyer NOT collect puppy by 10 weeks old without prior arrangements for extended boarding being discussed, the puppy and ALL funds, deposit, and remainder of final payment are forfeited by Buyer to compensate Seller for, vet care, and housing until the puppy is placed in a new home.

TERMS OF CANCELLATION

As the breeder, raiser, and inherent caretaker of the puppies, Seller reserves ALL RIGHTS to cancel the sale at ANY point in time and for ANY reason Seller deems fit. Should Seller cancel the sale, Buyer will receive a refund of the deposit amount and any monies paid toward the total sale price of the puppy EXCEPT if the cancellation of purchase is due to Buyer backing out for any reason including but not limited to change of mind, not completing payment at the time of transfer, failure to pick up puppy by 10 weeks of age, in which case NO REFUNDS in any amount will be made.

BINDING CONTRACT
